# Client Internet Policy

## **Computers are to be used for Employment Purposes Only**

Internet access has been established for limited employment development purposes only.

**Goodwill Industries of Central Florida, Inc. has the right to place reasonable restrictions** on the material accessed or posted through the system. As a user of this system, you are expected to follow the law in the use of the Internet and network resources.

## **Client Internet Access**

Only specific authorized e-mail access will be permitted by the Program Manager.

## **Unacceptable or Illegal Activities**

The following uses of Goodwill computers **are considered unacceptable** or illegal activities and may result in immediate removal from our Goodwill Job Connection Centers:

- You may not use the Internet for commercial purposes. This means you may not offer, provide or purchase products or services through the Internet at any Goodwill site using any Goodwill resource.
- Do not attempt to gain unauthorized access to the Goodwill network or to any other computer system through the Internet or go beyond authorized access. This includes attempting to log in through another person's account or access another person's files. These actions are illegal even if only for the purposes of "browsing."
- Do not make deliberate attempts to disrupt the computer system or destroy data by spreading computer viruses or by any other means. These actions are illegal [F.S.815 Computer Related Crimes].
- Do not use the Goodwill network to engage in any illegal act, such as arranging for a drug sale or the purchase of alcohol, engaging in criminal gang activity, threatening the safety of persons, etc.
- Restrictions against inappropriate language apply to public messages, private messages and material posted on web pages.

## **System Security**

Clients are responsible for the individual network access and must take all reasonable precautions to prevent access by others.

## **Client Rights**

An individual search will be conducted if there is reasonable suspicion that you have violated this Policy, or the law.

Investigation will be reasonable and related to the suspected violation.

## **Due Process**

Goodwill administrators will cooperate fully with local, state or federal officials to any investigation related to any illegal activities conducted through Goodwill network access.
